Notes From the Adjutant's Desk

First off, let me wish everyone reading this article a JOYOUS HOLIDAY SEASON! Many of us have celebrated in snow in past years and have given up on the "shoveling scene" that this time of year brought to us. I, for one, don't miss it at all! I love being here in Florida with friends and family and able to "bask in the sun!" I truly hope that this year has been a good one for you and that 2017 will be even better.

If you missed it, we had a good turnout this year at the Christmas Dinner at Perkins! We had 14 people in attendance this year and I am proud to be associated with such fine veterans and their families!

This year leaves us with some changes at the Post and the area.

- The Vaughn Property has been sold and will be developed into apartment housing over the next year or two. At this time, we are not certain how this will impact the Post and we are hoping for the best.
- We expanded the pavilion's hard surface and roof covering to allow for more people to attend our outdoor functions.
- We had insulation blown into the attic space to reduce the cost of heating and air conditioning costs.
- We replaced our 20-year-old air conditioning with a new, state of the art, heat pump. We increased the size of the system, again, in hopes of reducing our environmental costs. We also got a small rebate from the power company for these improvements. Hopefully we will begin to see the fruits of our labors as the new year comes in.

Activity-wise, we hosted our first ever Marathon. It was a success and brought money in for the Post as well as the Sea Cadets. Commander Dover and Judge Advocate Paulson have participated in marathons and were able to provide the guidance needed to make this a success for a first attempt. We will discuss doing this again next year in future months. We had 5K, half and

full marathon runners and everyone was done before 2 p.m. so it made for an interesting morning for the runners and the workers. Want to have some FUN? Why not volunteer to help out next year? We'll keep you posted on the progress.

We hosted the "Four Chaplains Ceremony" again this year and it was one of the finest in the District. Jerry is already working hard on the 2017 event to make it the best one yet!

We had two Craft and Yard sales during the year. The one in the Spring didn't do all that well as the weather and the general feelings about the economy put a damper on it. The Fall Craft and Yard Sale did much better even though we didn't have as many vendors/sellers as we would have liked. The weather was beautiful and you could see that everyone was in good spirits.

We again partnered with our Auxiliary Unit to deliver food baskets to Veteran families in need in the Winter Park/Goldenrod area. And this year, our Sons of the Legion Squadron joined the fun. The Auxiliary members procured the necessary baskets and shopped for the food that went in the baskets; the Auxiliary, S.A.L., and Legion representatives then made the deliveries just before the Christmas holiday. This is a great example of our Legion family working together to support local Veteran families! I would urge you to support the Auxiliary and Sons projects throughout 2017 as they are announced as *we are a family* and family supports family.

Two events that didn't happen this year would have been back to back and they were the Legion Family Picnic and the "Boy Scout Jamboree on the Air." Both were impacted by Hurricane Matthew. We had planned them but had to cancel them in lieu of the hurricane as a safety precaution.






We do hope that everyone had a very Merry Christmas.

In January, our Unit will shop for and deliver school supplies and food items to our elementary schools to support their pantries that support low income and homeless families. Please pick up some school supplies like notebook paper, Duotang folders, crayons, pens, and pencils and drop them off at the Post whenever you come. The

schools also have food pantries that help to supplement the evening meal needs of the students. We need items like Macaroni and cheese dinners, peanut butter, jelly, canned tuna, etc. A new project that we will be starting in January is a clothing project for the elementary schools. The children from low income families often come to school without socks, or, when accidents occur during the school day, have no clean underwear into which they can change. We are collecting youth sized socks, girls and boys underwear, etc. Please support our new project and drop off your donations at the Post.


