Notes From the Adjutant's Desk

HAPPY NEW YEAR!

2018 is now over and we can look forward to 2019. With the new year comes some changes around the Post. Among other things, you may have noticed the new roadway and fence around the Post. These changes came from the apartment development behind the building but in the process, we lost parking along the front of the building. The first thought was to park on the grass in front of the Post; there is a gate of sorts that will be put there. But, that turned out to be a bad idea. The grass is soft and the traffic on it would destroy the looks of the Post from the roadway as well as present some issues for those walking across it. So, it was decided that the parking would be at the "rear" of the Post, in the Cellular Tower area. There is a gate at the end of the road by the apartments where the curbing is lower and it will allow traffic into the back side of the Post. There is also a door in to the building on that side that will be available during meetings and activities for access. The concrete pad by the fence line (inside the fence) will become handicapped parking and we are working to put in a sidewalk from the handicapped parking around to the front where the ramp will allow our less mobile members to come inside. We are also improving the lighting around the outside of the building to give everyone a safe pathway.

Membership is being handled by Steve Miglionico as far as making contact for renewals in addition to the notices that National sends out. Steve has helped get us past 70% and he is working to get us to 100% by the end of January. If you haven't paid your 2019 dues, please drop your check in the mail today as your 2018 membership expired on December 31st.

Another project in progress is the updating of the Post's Constitution and By-Laws as well as adding "Standing Rules" which will be something new for us. The current Constitution and By Laws are

We hope to have the amendments ready in the near future but there is no specific date. If you have something to propose, send it to me and I will share it with the Commander and the Executive Board to consider your suggestion. Also, suggestions for the Standing Rules are requested. The reason for the Standing Rules is that National has recommended that items like dues and meeting days be covered there rather than in the actual Constitution and By Laws, thus allowing us to keep things current with a minimum amount of work.

Let's all make it to the January meeting to hear what else is new and upcoming. February will be the meeting where we will be selecting our four Boy's State candidates and their alternates.



Notes from Our Service Officer

Welcome to the New VA.gov — Built with Veterans, for Veterans

This new site offers one place to access all VA benefits and health care services. I have used it personally and is easy to navigate, log into and find information you cannot get by making phone calls. You can sign in with your My HealtheVet, DS Logon, or ID.me account to track your claims, refill your prescriptions, and more. This started as Vets.gov but once you get there, it redirects you to VA.gov. Below are some of the items you can find there by clicking on the links.

The VA Mission Act of 2018 provides new funding for the Veterans Choice program and will eventually (approximately 1 year) be replaced with the Mission Act. New laws, policies, training and regulation must be implemented prior to having a fully functional Community Care program. This will allow Veterans to choose/use facilities outside of the VA and have the service covered by the VA. Stand by for more on this as I find out more information.

Arlington National Cemetery Update:

With the holiday season in full force, volunteers are needed to place wreaths at Arlington National Cemetery for an annual event held every December to honor our nation's fallen veterans. The organization Wreaths Across America is looking for people to join them on National Wreaths Across America Day to place 246,700 wreaths on all headstones and markers at the Arlington, Virginia cemetery. This year, it will be held on Saturday, 15 DEC. A convoy of tractor trailers carrying more than 250,000 balsam wreaths will be leaving from Maine on 8 DEC for the weeklong voyage to Virginia.

The Wreaths Across America annual escort of handmade, balsam wreaths has become known as the country's longest veterans' parade. Marshal – National President of American Gold Star Mothers Inc., Becky Christmas – will lead the caravan as it travels down the East Coast stopping at schools, memorials and other locations along the way **Continued on Page 7**

to spread the mission to REMEMBER, HONOR and TEACH. More than 75,000 volunteers gathered at Arlington National Cemetery to take part in last year's event. In addition to volunteering, the non-profit group also seeks donors to help raise money for the wreaths. The cost to sponsor a veteran's wreath is \$15. USS Thresher Memorial ► Arlington National Cemetery Memorial Project

U.S. senators from three New England states recently wrote a letter urging Secretary of the Army Mark Esper to consider the USS Thresher Arlington National Cemetery Memorial Project, to establish a monument honoring the 129 men who perished aboard the submarine. USS Thresher sank off the coast of New England April 10, 1963. The submarine was built and maintained at Portsmouth Naval Shipyard. In response to the Thresher tragedy, the U.S. Navy instituted a new program to ensure the health and safety of U.S. submarines, establishing the Submarine Safety and Quality Assurance Program. SUBSAFE is one of the world's most comprehensive military safety programs and has helped provide maximum protection for Navy crews. No SUBSAFE certified submarine has ever been lost.

MEMORIAL: Ray Chavez, widely recognized as the oldest-surviving veteran of the attack on Pearl Harbor, died Wednesday at the age of <u>106</u>. He spent nine days on continuous duty in and around Pearl Harbor and said the scenes he witnessed left deep emotional scars. Over the next four years he rose to the rank of Chief, serving on transport ships that delivered tanks and Marines to shore in eight Pacific battles. Although he wasn't injured during the war, he retired from the Navy in 1945 with psychological wounds from the terrible things he witnessed

"Keeping the Promise", "Fulfill their Trust" and "No one left behind" are several of many mottos that refer to the efforts of the Department of Defense to recover those who became missing while serving our nation. The number of Americans who remain missing from conflicts in this century are: World War II 73,025, Korean War 7730, Vietnam War 1604, Cold War (126), Iraq and other conflicts (5). Family members seeking more information about missing loved ones may also call the following Service Casualty Offices: U.S. Air Force (800) 531-5501, U.S. Army (800) 892-2490, U.S. Marine Corps (800) 847-1597, U.S. Navy (800) 443-9298, or U.S. Department of State (202) 647-5470.

This week, the Defense POW/MIA Accounting Agency announced 13 new identifications. Returning home with full military honors are: 5 Army (Germany), 3 Marine Corps (Vietnam, Korea and Pearl Harbor) and 5 Navy (Pearl Harbor) service members.
