

## **VA Mission Act Update**

## **Choice Program Ending, Replaced by New Community Care Program:**

The Veterans Choice Program is scheduled to be replaced by a new Veteran Community Care Program; the VA MISSION Act. President Donald J. Trump's signature put us on a path to implementing these reforms. On June 6, the MISSION Act will enable VA to consolidate the Department's community care efforts into a single, simple-to-use program that will empower Veterans with the ability to choose the healthcare providers they trust.

So what can Veterans expect on June 6?

Less red tape, more satisfaction and predictability for patients, more efficiency for our clinicians, and better value for taxpayers. Veterans will be eligible to get community care for a variety of reasons, including when VA can't provide the treatment they need or when care outside our system is in the best medical interest of the patient.

To ensure our Veterans are spending their time getting care instead of driving to it, patients facing an average drive time of 30-minutes or more for VA primary or mental healthcare, or non-institutional extended care services, will have the option of choosing a community provider closer to home. For specialty care, the drive-time standard will be an average of 60 minutes.

And to get Veterans the care they need when they need it, VA patients facing a 20-day or more wait time for primary or mental healthcare, or non-institutional extended care services, will have the option of choosing a community provider who can deliver that care faster. For specialty care, the wait-time standard will be 28 days.

For additional convenience and timely treatment, eligible Veterans will also have access to

urgent, walk-in care that gives them the choice to receive certain services at participating community clinics in their communities. (To access this new benefit, Veterans will select a provider in VA's community care network and may be charged a copayment.)

## D-Day 75th Anniversary at National WWII Memorial:

The Friends of the National World War II Memorial will be hosting three events beginning Wednesday to commemorate the 75th anniversary of the D-Day landings. First up will be a discussion of the new book, "The First Wave: The D-Day Warriors Who Led the Way to Victory in World War II," at 10 a.m. at The Army and Navy Club at Farragut Square. This will be followed. by a remembrance ceremony, candlelit vigil, and a reading of the names of those who are buried at the Normandy American Cemetery in France Wednesday afternoon at 4 p.m. The 75th anniversary ceremony begins at 10 a.m., Thursday.

## Politics and the Legion Family

With the upcoming political season starting, there is something that you need to know about the American Legion, Auxiliary, and the Sons of the American Legion and the policies regarding politics and the American Legion family emblem and symbols.

The American Legion family is "a-political" and that means that the Legion family of organizations supports and encourages the act of voting in all forms but the Legion, Auxiliary, and S.A.L. can not back or support a particular candidate regardless of the office that this person is hoping to attain. That means, specifically, NO HATS, CAPS, SHIRTS, OR ANY OTHER SYMBOL OF THE AMERICAN LEGION, THE AMERICAN LEGION AUXILIARY, OR THE SONS OF THE AMERICAN LEGION MAY BE DISPLAYED AT A POLITICAL RALLY, MEETING, MARCH OR CAMPAIGN. You as a Legion family member are encouraged to participate in such activities but you do it on your own, as it should be.

The appearance of a cap, shirt or other symbolism of the American Legion, the Auxiliary, or the S.A.L. at a political function for any candidate gives the **FALSE** impression that the Legion family supports that person, and that is forbidden by the Legion's rules and policies.

The American Legion is a Federally Chartered Organization and prohibited from participating in, or endorsing any individual or Political Party. While the American Legion Auxiliary and the Sons of the American Legion are not federally chartered, they cannot exist without the American Legion and must, therefore, abide by the rules of the American Legion.

## Coyotes and Your Pets



There have been numerous sightings of coyotes in our area. This is just a reminder that coyotes roam our neighborhoods in search of shelter and, of course, food. Coyotes live in every state in the US except Hawaii. Coyotes are curious but are also timid and will run away if challenged. These animals resemble a small German Shepherd dog and weigh between 15 and 30 pounds. The coyote diet consists of just about anything they can find including pet food, fruits, nuts, seeds, dead animals, and rodents, <u>as well as domestic cats and small dogs.</u> Coyotes will also eat garbage if they can get to it. Please make sure that your garbage cans are securely closed

when you put them out for collection and that you are not leaving dishes of pet food outside.

Most coyote attacks on animals occur overnight, at dawn, or at dusk. If you can avoid walking your dogs at these times, it is best to do so. If you must walk your dog during these peak attack times, please be sure to keep your dog on a short leash. And please keep your cats indoors over night. To protect your animals when you walk them, you might consider carrying a large squirt gun, walking stick, golf club or air horn with you. **Trusted Advisors (Legal & Financial) -** Be sure to include your attorney and financial planner in the decision making process. If you don't have a family lawyer, you may want to consider working with an elder law attorney.

#### STEP 2: Decide Where to Move:

- 1. Locally
- 2. To a different city
- 3. To a different state

#### STEP 3: Decide what size and type of new home would best suit your needs:

Smaller house

Apartment

Condo

Retirement community Assisted living facility

RV & travel the world

#### STEP 4: Decide what to take to your new home.

If none of the organizations you currently support could benefit from what you want to donate, consider a reputable national charity such as Good Will, Habitat for Humanity, or the Salvation Army. **Sell -** Once you've determined what you are keeping, gifting and donating, it's time to figure out how to sell the rest. If you want to sell things yourself, options to consider include:

## Hurricane Preparedness

Welcome to the 2019 Hurricane Season! June 1<sup>st</sup> is no longer "around the corner" in fact, it is HERE! And to help you along with the idea, here are the 2019 names for these storms:

Andrea; Barry; Chantal; Dorian; Erin; Fernand; Gabrielle; Humberto; Imelda; Jerry; Karen; Lorenzo; Melisa; Nestor; Olga; Pablo; Rebekah; Sebastien; Tanya; Van and Wendy. This list can but hopefully will not be expanded as needed through the season.

To many of us, the season is something to note but not be too concerned about until August or September. Face it, the bulk of the storms that come our way are during the peak of the season. Our last storm was in 2017 which wasn't that long ago. Were you a resident then? If so, you may have experienced some damage, or inconveniences AND power outage. Many of us were without power for over a week that time. And, as some will tell you, with power outages comes loss of cable/internet and landline (home phone) if you use the internet for your phone service. So, let's go over a couple of things.

Power loss means that your freezer is not going to keep the contents frozen for much more than 24-48 hours. What you can do is obtain a relatively small (5KW-9KW) gasoline generator and some heavy duty extension cords. That size generator will keep both the freezer and refrigerator operating. It will NOT give you hot water or run your stove/oven and maybe not even your microwave oven unless you unplug the freezer and refrigerator first. But, with the freezer and refrigerator covered, food will not spoil.

Cooking could be a problem that is easily solved with an outdoor grill, provided that you have one that has propane or the charcoal already here. If you are like many of our neighbors, outdoor cooking is a specialty! Again, be certain that the ventilation is taken care of and never bring the grill inside the garage or house.

**REMEMBER---NEVER USE A GENERATOR IN THE GARAGE OR NEAR YOUR DOORS OR WINDOWS!!!** Carbon monoxide is colorless and odorless and DEADLY. If you or anyone in the house is **beginning to get headaches**, shut the generator OFF and move outside while you ventilate your house **AND CALL 9-1-1!** Rescue needs to check everyone out after exposure to carbon monoxide.

Happy Hurricane Season – 2019! I sincerely hope that we don't have to use these skills this year.
