## Notes From the Adjutant's Desk

## VA Cemeteries Offering Pre-Enrollment

The Department of Veterans Affairs (VA) recently announced that it now provides eligibility determinations for interment in a VA national cemetery prior to the time of need. Through the Pre-Need Determination of Eligibility Program, upon request, individuals can learn if they are eligible for burial or memorialization in a VA national cemetery. Secretary of Veterans Affairs Robert A. McDonald said, "This new program reaffirms our commitment to providing a lifetime of benefits and services for veterans and their families." Now veterans and their families can plan for their burial needs which will alleviate some of the burden later.

Interested individuals may submit [VA Form 40-10007](#), *Application for Pre-Need Determination of Eligibility for Burial in a VA National Cemetery*, and supporting documentation, such as a DD Form 214, if readily available, to the VA National Cemetery Scheduling Office by toll-free fax at 1-855-840-8299; email to [Eligibility.PreNeed@va.gov](mailto:Eligibility.PreNeed@va.gov); or mail to the National Cemetery Scheduling Office, P.O. Box 510543, St. Louis, MO 63151.

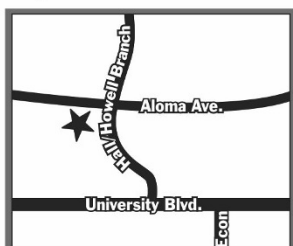

During February drill we had part of the battalion at a field training exercise (FTX) in Groveland, Florida leading leadership, land navigation, and activities of zip-line as well as working with three other units. It was a privilege to assist the Post 112 in the FOUR CHAPLAIN's Service which has a deep meaning to all, for the chaplain's willingness to sacrifice it all for their fellow comrades.

The battalion has now reduced its numbers in a good way, by establishing another unit in the Clermont area. While at one time we were one big unit we now have new units in Clermont, Sanford, Fruitland Park. This means we are reaching more cadets and teaching them the HONOR, COURAGE and COMMITMENT are the new standards in their lives.
