

Notes from Our Service Officer

Verify Veteran Status From Your Smart Phone

In addition to a Veteran ID Card now there's another option for every Veteran to verify his/her veteran status. Using the Armed Forces Locator (AFL) platform, Veterans who need help verifying their identities to businesses can simply logon to their AFL account to prove their Veteran status. If disabled, all a Veteran has to do is set up disabled status on their on their AFL account as proof. It's simple, and worth setting up as a secondary verifying source.

Using the AFL platform, you can upload your DD 214, DD 256 Form (Discharge Certificate), and other military forms to prove your veteran status. Creating an AFL account, you will have many options to prove your veteran status to businesses, employers, family and friends, right from your smart phone.

Why you should create an account on AFL?

By creating an account with AFL, you gain access to a suite of free tools to showcase your military career. Also, with an AFL account you can:

- Respond to member reviews with a direct message or public comment
- Reply to messages from other AFL members.
- Track views on your AFL account
- Upload military documents
- Upload VA documents
- Upload military awards
- Upload and manage military photographs
- Update your contact information like address, telephone number, website
- Add further information to your Homepage, like military biography
- Locate military buddies
- Locate military dependents

Locate military organizations

On Thursday, the House also passed H.R. 450, the Preventing Crimes Against Veterans Act of 2019, which would punish with up to five years imprisonment whoever defrauds veterans of their earned benefits.

Senate Appropriations Hearing on Electronic Health Care Record Modernization: On Tuesday, the Senate Committee on Appropriations Subcommittee on Military Construction, Veterans Affairs, and Related Agencies held a hearing on the implementation of VA's electronic health record modernization (EHRM) efforts. The hearing focused on how the VA plans to stay on track during the estimated 10-year, \$16.1 billion transition to the

The Veterans Appeals Improvement and Modernization Act of 2017 is effective February 19, 2019. Under the new law, any Veteran who receives an initial VA claim decision after February 2019 can choose from three, easy-to-understand review choices. All three choices provide Veterans with faster resolution of disagreements with VA decisions.

The new law will:

EHRM.

Modernize the current claims and appeals process

Include three review options for disagreements with decisions

Require improved notification of VA decisions Provide earlier claim resolution

Ensure you receive the earliest effective date possible

- Option 1: Higher-level Review
 - Your claim is reviewed by a more senior claims adjudicator and involves:
- Option 2: A Supplemental Claim Lane

You can submit or identify new and relevant evidence to support your claim. VA will provide Continued on Page 8

Assistance in developing the evidence.

• Option 3: Appeal Lane for Appeals to the Board

This option allows you to appeal directly to the Board of Veterans' Appeals. You can choose between three options:

- ♦Direct review: You have no new evidence and do not want a hearing.
- ◊Evidence submission: You have new evidence, but do not want a hearing.
- ♦ Hearing: You have new evidence and want to testify before a Veterans Law Judge.

MIA Update: This week, the Defense POW/MIA Accounting Agency announced four new identifications. Returning home with full military honors are: 2 Amy (Germany) and 2 Marines (Pearl Harbor).
