## Notes From the Adjutant's Desk

Wow! Changes around the Post is only party of the news this month. We received word that the new sign should be ready around the end of March, so the April meeting would be a great time to come and see it! The 2018 Department Convention is coming, so you can plan to attend that, too.

HELP WANTED! This is a for real call for your help. We will be having Post elections soon, and the following positions are looking for nominees: 2nd Vice Commander, Historian, and Chaplain. The positions that have nominees at the moment are: Commander, 1st Vice Commander, Finance Officer and Sergeant At Arms. So, to give you an idea of what you would be doing, here are the job descriptions:

Commander: The Commander shall be the executive head of the Post with full power to enforce the provisions of the Constitution and ByLaws. He shall be the chairman of the Executive Committee. He shall perform such other duties as are usually incident to the office.

Vice Commander: The Vice Commanders shall act as representatives of the Post on all matters referred to them by him, and shall, on his request, preside over the meetings of the Executive Committee, and perform such other duties as are usually incident to the office.

1st Vice Commander duties include overseeing Post Membership.

2nd Vice Commander duties include overseeing the Post Facilities and assisting in Post Meeting Programs.

Finance Officer: The Finance Officer shall be the custodian of the funds of the Organization. He shall sign all checks disbursing the funds of the National Organization, and shall make reports upon the condition of the treasury when called for by the Commander. He shall perform such other duties as are usually incident to the office.

Chaplain: The Chaplain shall perform such divine and nonsectarian services as may be necessary, adhering to such ceremonial rituals as may be recommended by National Headquarters from time to time.

Historian: The Historian shall collect from year to year all records and data of value and interest for the Post, and shall compile during his term of office a complete history of the year's activities.

Sergeant At Arms: The Sergeant-At-Arms shall preserve the order at the meetings of the Post and meetings of the Executive Committee and perform such other duties as may be prescribed by the Executive Committee, and he/she is authorized to appoint such assistants as he/she may choose

We will also be looking for people to chair committees. These are appointed positions that are approved by the Executive Board each year.

The committees that we currently have are: Americanism, Baseball, Boy Scouting, Blood Donor, Boys State, Constitution and By-Laws, Disaster Preparedness, Employment, First Responder of the Year (combined police and fire but can be split), Military Family & Veterans Assistance, Oratorical, ROTC, Shooting Sports, and the Nominating Committee. If any of these areas interest you, please contact me for the details. Many of these areas are inactive due to a lack of someone to "champion" them. There is no reason why we can't start them up if you have the interest. In April, we hope to be able to tell you which committees still need Champions (chair people).

Nominations from the nominating committee will be submitted to the Post at the May meeting but we will talk about it at the April meeting. The election will be held at the June meeting.



\*New Online Tool Will Provide Veterans with Customized Instructions for Discharge Upgrade Process

WASHINGTON — The Department of Defense (DOD), through a joint initiative with the U.S. Department of Veterans Affairs (VA), has launched a new web-based tool that will provide customized guidance to Veterans who desire to upgrade or change the conditions of their military discharge. By answering a few short questions, Veterans will receive information on the specific armed services board to contact, the form/s to fill out, special guidance applicable to their case, where to send their application and helpful tips for appealing their discharge.

"This new tool and partnership with DOD is one of many VA initiatives offered to Veterans who believe they may have been unfairly discharged or received an unfair discharge characterization," said VA Secretary Dr. David J. Shulkin. "Veterans who believe their discharge was unjust, erroneous or warrants an upgrade are encouraged to use the tool and then apply for review."

DOD officials also praised the new innovative tool. "We are thrilled to have partnered with the Department of Veterans Affairs in devel-

oping this wonderful and easily accessible tool," said Mr. Robert Wilkie, Under Secretary of Defense for Personnel and Readiness. "We support our Veterans, whether they served recently or long ago, and we are excited to introduce a tool that will individualize the guidance for those who desire an upgrade or change in their military discharge."

The military has estimated that tens of thousands of Veterans with less than honorable discharges are especially likely to have unjust discharges deserving of upgrades. These are Veterans who were discharged due to incidents relating to post-traumatic stress disorder, traumatic brain injury or sexual orientation. Fragmented and confusing information has historically deterred Veterans from obtaining crucial information and — in many cases — necessary benefits.

The discharge upgrade tool is available at <a href="https://www.vets.gov/discharge-upgrade-instructions">https://www.vets.gov/discharge-upgrade-instructions</a>.

On November 1, 2017, we launched the Rapid Appeals Modernization Program, or "RAMP," with the goal of providing eligible Veterans with the earliest possible resolution of their disagreement with VA's decision on their benefit claims. RAMP expands opportunities to enter the new, more efficient claims review process outlined in the historic Veterans Appeals Improvement and Modernization Act of 2017, which was signed into law by President Donald J. Trump on Aug. 23, 2017. In November 2017, we began to send invitations to eligible Veterans with some of the oldest pending legacy appeals. We will be

sending monthly mailings to participate in RAMP until February 2019. Eligibility for voluntary participation is based on receiving an invitation letter from us.

\*Thinking of filing another VA disability compensation claim? Make sure you file it through the new Decision Ready Claim (DRC) Program. With DRC, you can get a decision on your claim in 30 days or less.

Work with an accredited Veterans Service Organization (VSO) to determine if the DRC Program is right for you and your claim. Your VSO can then help you gather and submit all relevant and required evidence so your claim is ready for VA to make a decision when you submit it. If you plan to file any of the following types of claims, work with your VSO to file them as a DRC:

- **Direct Service Connection Claims**: Claims for a disability that was caused by or during your service.
- Presumptive Service Connection Claims: Claims for a disability that VA automatically presumes to be service-connected based on unique conditions or situations you experienced during your service.
- Secondary Service Connection Claims: Claims for a disability that you have as a result of another service-connected disability.
- Increased Disability Claims: Claims for a disability you have a VA rating for that has gotten worse.

# Squadron 112 Salutes Navy Veteran Elmer Brown of Memorial Post 112

The Sons of the American Legion at Squadron 112 would like to take this time to thank Elmer Brown for his Military service and recognize him for being the oldest member of Memorial Post 112 in Winter Park Florida.

Elmer Brown was born on June 17, 1916 in Atwood, Kansas a small town tucked away in the northwest corner of the state, not far from the Colorado and Nebraska borders. Elmer's family moved to Engle Wood, Colorado when he was 2 years old after his father passed away from the Flu pandemic of 1918.

Elmer later became interested in boxing and fought in the 118 pound weight class. During his early years of boxing, winning included a new suite of clothes instead of money. Elmer never lost a fight and once beat a fighter who went to the Olympic Trials in Boston Massachusetts. Elmer did not participate in the Olympic Trials because he could not afford the trip. A 1937 Denver newspaper photo of Elmer in the ring sporting boxing gloves still hangs from the

living room wall. Elmer said, "I was never hurt, knocked down or knocked out, I won every match I ever had.

Elmer joined the Navy in 1941 at the age of 25 years old. He was assigned as a Seaman to the USS Melville, a repair ship that travelled with the Fleet. During his 30 year career he was assigned to the USS Amphion, USS Northampton and the USS Thuban. Elmer recalls visiting Hawaii and leaving just 2 weeks prior to the Japanese attack on Pearl Harbor. countries visited by Elmer during his Naval Career include Brazil, the Caribbean Islands, Northern Europe, Greenland, Iceland and the Mediterranean.

Elmer remembers one trip ashore during WWII in Rome, Italy where he met and shook hands with Pope Pius the XII who thanked Elmer for his service.

Elmer's tenure while in the Navy had no shortage of thrills and close calls. He remembers being ashore in England one night when air Raid sirens went off. group ran back to the docks to board their ship but, had to jump a fence and dash across a wide open field. The group jumped a second fence and when they looked back the sign read, "WARNING MIND FIELDS".

While in the Navy and stationed in Jacksonville Florida, he met his future wife Christine. Christine was a seamstress by trade and very supportive of Elmer and his career in the Navy. Christine willingly volunteered her services to sew patches on his Navy uniforms.

Elmer's last duty assignment in the Navy was to help build the Recruit Training Center here in Orlando Florida. After retiring in 1971, he spent the rest of his working career in the air conditioning and refrigeration business in Central Florida.

Today, Elmer lives with his son Donn and his wife Suzi in their Winter Park Home. Don recalls recently finding Elmer trying to fire up a lawn mower in the back yard on a hot afternoon, despite Elmer's ripe old age of 101 years old and dependence on a cane.

Elmer was once asked, how to you reach the age of 101 years old? Elmer replied, "you just need to keep busy".

## The Wearing of the Cap and Usage of The American Legion Emblem, Facilities and Political Donations

According to Article II, Section 2, of the Constitution of The American Legion, "The American Legion shall be absolutely nonpolitical and shall not be used for the dissemination of partisan principles nor for the promotion of the candidacy of any person seeking public office or preferment." The National Charter, approved by Congress, also stipulates The American Legion as an organization is nonpolitical\* which has been interpreted by the National Judge Advocate as "nonpartisan" in modern lingo. Therefore, The American Legion as an organization is prohibited from contributing, helping or endorsing a candidate. However, a member, as a private citizen, and not representing the organization, can employ whatever legal and ethical means to advance his or her candidate.

The Legion cap is considered the official Legion uniform (see p. 42). It

is not an individual Legion member's decision on the appropriate usage of the cap and emblem. If attending a political event, The American Legion cap, or any clothing with the emblem visible, should be removed so as not to imply endorsement by The American Legion. The problem is the assumption of endorsement by those who see the emblem or name worn at in improper location, such as a partisan rally.

When using post facilities to host candidates, post should remove emblem and Legion flag to avoid any impression of endorsements. Candidates for all parties must be presented equal opportunity at the same time to use the facilities on the same terms and conditions as other competing candidates.

If financial contributions are offered by candidates for political office, campaigns, political action committees or political parties, The American Legion should politely decline. Accepting these contributions may be perfectly legal, but The American Legion must avoid any perception of supporting any candidate or political party.

The American Legion values its independence and effectiveness on veterans' issues. This stance is best maintained by neutrality on individual candidates or political parties. The American Legion by legal definition is non-partisan and supports only issues which impact your Four Pillars..

\* This means "non-partisan" in today's society. The American Legion is allowed by Congress to lobby for veterans benefits and a strong United States of America. (NJA, October 25, 2012)

In November 2017, we began to send invitations to eligible Veterans with some of the oldest pending legacy appeals. We will be sending monthly mailings to participate in RAMP until February 2019. **Eligibility for voluntary participation is based on receiving an invitation letter from us.** 

If you have already received a RAMP invitation, and have questions about this opportunity or need assistance, please contact your representative (Veterans Service Organization, attorney, or claims agent). Your representative can assist with the best review option for your appeal(s) and can also file an election on your behalf.

If you don't have a representative and would like to find an organization or individual to assist you, or if you want to change your representative, you can use <u>eBenefits</u> to see a list of VA-recognized Veterans Service Organizations and accredited attorneys and claims agents. You can also use eBenefits to appoint your representative.

We will continue to work closely with Congress, Veterans Service Organizations, and other Veteran advocates to implement the new appeals process over the next several months as we continue to make bold, positive change on behalf of Veterans, their families and survivors.
