# Nominating Committee Update

Per our Constitution and By Laws, there are no nominations made on the election day.

What does this mean to you? The Service Officer must also be certified by Department which means that he or she has to take the "Service Officer's Course" at the Convention or Fall Conference. As a rule, present chairpersons are asked if they will continue before a replacement is sought.

Page 9 of this newsletter has detailed descriptions of the offices and their duties. Ladies and Gentlemen we are rapidly approaching the end of the 2017-2018 year. The Post's fiscal year runs from July 1 to June 30 and now is the time to begin thinking about the 2018-2019 Officers. 

#### Notes from Our Service Officer

OTH VETERANS FILE LAW-SUIT AGAINST DOD - Thousands of Navy and Marine Corps veterans who served in Afghanistan or Iraq and have an Other Than Honorable (OTH) discharge, recently filed a class-action lawsuit against the Department of Defense (DoD). The plaintiffs feel they were unfairly given less-thanhonorable discharges by the Navy, preventing them from getting their benefits. The veterans are represented by students from Yale Law School's Veterans Legal Services Clinic. which filed a similar lawsuit against the Army last year.

DoD and the Department of Veterans Affairs (VA) recently launched a web-based tool that provides customized guidance to veterans who desire to upgrade or change the conditions of their military discharge. The tool can be found at Vets.gov site. The link is also available on Military OneSource as well as each of the review board's links listed on the Navy Board for Correction of Naval Records website.

#### **MEDICARE SCAM ALERT!**

The Scam: Someone from Medicare will call you and say that you're getting a new card; they will say that until it comes, you will need a temporary card that costs between \$5 and \$50. And then they will ask for your bank information and credit card information to process the temporary card. Please Don't. This is a scam. The Facts:

1. Medicare communicates only by mail, unless you tell them to call you.

Starting on April 1, 2018, Medicare will begin a year-long program to replace all current Medicare beneficiary cards to convert to alphanumeric ID numbers. Currently your ID number is your social security number. All the new Medicare cards will come in the mail; you don't need to do anything. Your Medicare card will show up.

MIA Update: The Defense POW/MIA Accounting Agency has announced identification and burial updates for eight American service members who had been missing in action from WWII and Korea. They will be returning home for burial

with full military honors. Three Navy, Three Army and One Marine Veterans.

#### **Expanded Chiropractic Care** for Veterans Passes

The recently passed omnibus spending bill for FY2018 includes a provision to expand access to chiropractic's nondrug approach for pain relief to veterans. There are many veterans suffering from back pain and other musculoskeletal conditions as a result of their time in service. This mandates that the Department of Veterans Affairs (VA) expand the availability of chiropractic services at no fewer than two medical centers or clinics in each Veterans Integrated Service Network (VISN) by no later than Dec. 31, 2019; and at no fewer than 50 percent of all medical centers in each VISN by no later than Dec. 31, 2021. For the first time, the measure codifies and broadens chiropractic services in the VA to include services provided by doctors of chiropractic under the Preventive Health Services and Medical categories.

# Post Officer Roles and Responsibilities

The Nominating Committee is working hard to build a slate for our June election. Listed below are the roles and responsibilities of all Post officers:

Commander: The Commander shall be the executive head of the Post with full power to enforce the provisions of the Constitution and ByLaws. He shall be the chairman of the Executive Committee. He shall perform such other duties as are usually incident to the office

Vice Commander: The Vice Commanders shall act as representatives of the Post on all matters referred to them by him, and shall, on his request, preside over the meetings of the Executive Committee, and perform such other duties as are usually incident to the office.

- 1st Vice Commander duties include overseeing Post Membership.
- 2nd Vice Commander duties include overseeing the Post Facilities and assisting in Post Meeting Programs.

Finance Officer: The Finance Officer shall be the custodian of the funds of the Organization. He shall sign all checks disbursing the funds of the National Organization, and shall make reports upon the condition of the treasury when called for by the Commander. He shall per-

form such other duties as are usually incident to the office.

Chaplain: The Chaplain shall perform such divine and non-sectarian services as may be necessary, adhering to such ceremonial rituals as may be recommended by National Headquarters from time to time.

**Historian:** The Historian shall collect from year to year all records and data of value and interest for the Post, and shall compile during his term of office a complete history of the year's activities.

Sergeant At Arms: The Sergeant-At-Arms shall preserve the order at the meetings of the Post and meetings of the Executive Committee and perform such other duties as may be prescribed by the Executive Committee, and he/she is authorized to appoint such assistants as he/she may choose

We will also be looking for people to chair committees. These are appointed positions that are approved by the Executive Board each year. Our committees are:

#### Federal Law Focuses on Elder Abuse

A new federal law is designed to address the growing problem of elder abuse. The law supports efforts to better understand, prevent, and combat both financial and physical elder abuse.

The prevalence of elder abuse is hard to calculate because it is underreported, but according to the National Council on Aging, approximately 1 in 10 Americans age 60 or older have experienced some form of elder abuse. In 2011, a MetLife study estimated that older Americans are losing \$2.9 billion annually to elder financial abuse.

The bipartisan Elder Abuse Prevention and Prosecution Act of 2017 authorizes the Department of Justice (DOJ) to take steps to combat elder abuse. Under the new law, the federal government must do the following:

- Create an elder justice coordinator position in federal judicial districts, at the DOJ, and at the Federal Trade Commission
- Implement comprehensive training on elder abuse for Federal Bureau of Investigation agents
- Operate a resource group to assist prosecutors in pursuing elder abuse cases

The law requires the DOJ to collect data on elder abuse and investigations as well as provide training and support to states to fight elder abuse. The law specifically targets email fraud by expanding the definition of telemarketing fraud to include email fraud. Prohibited actions include email solicitations for investment for financial profit, participation in a business opportunity, or commitment to a loan.

The law also addresses flaws in the guardianship system that have led to elder abuse. The law enables the government to provide demonstration grants to states' highest courts to assess adult guardianship and conservatorship proceedings and implement changes.

"Exploiting and defrauding seniors is cowardly, and these crimes should be addressed as the reprehensible acts they are," said Senator Chuck Grassley (R-lowa), a co-sponsor of the legislation, adding that the legislation "sends a clear signal from Congress that combating elder abuse and exploitation should be top priority for law enforcement."
