We didn't even have the Department Convention (or the National Convention) or the Fall Conference. We have canceled our annual picnic and Christmas Party for this year. And by the time you are reading this, we may have had a National General Election. It has been quite a year.

Now that the NEGATIVE stuff is out of the way, let's look forward! Commander Middlekauff has outlined much of the GOOD stuff. We have a new Four Chaplain's Memorial by the flagpole just waiting to be dedicated AND celebrate the Four Chaplains in February of 2021. ## Notes from Our Service Officer

The VA's National Cemetery Administration (NCA) is promoting pre-need eligibility determinations, to encourage Veterans and their eligible family members to plan to use VA burial benefits. Due to the unprecedented number of applications received, they have temporarily shifted their focus to notifying each applicant that they have received their application and communicating with them about expected timelines for completion of our determination. They expect to have this notification out to each applicant shortly. NCA provides eligibility and scheduling support to families with Time of Need requests for burial, meaning those circumstances where a death has occurred, and families need to schedule a burial at a national cemetery. If that is your situation, you should contact your funeral service provider or the National Cemetery Scheduling Office at 1-800-535 - 1117. NCA is no longer accepting email submissions for VA Form 40-10007, "Application for Pre-Need Determination of Eligibility for Burial in a VA National Cemetery." NCA hopes to resume this service in the future. It is continuing to process applications via the online application, mail, and fax. Please mail VA Form 40-10007 to: National Cemetery Scheduling Office P.O. Box 510543 St. Louis, MO 63151 Or fax to: Fax (toll-free): 1-855-840-8299

On Thursday, the first phase of the Program of Comprehensive Assistance for Family Caregivers (PCAFC) went live on VA's website. PCAFC offers education and training, access to health care insurance, mental health counseling, financial stipends, respite care, among other benefits for caregivers who care for an eligible veteran. As part of the *VA MISSION Act of 2018*, PCAFC will expand in two phases. The first phase is for caregivers of veterans who were injured in the line of duty on or before May 7, 1975. The second phase is for those injured in the line of duty between May 7, 1975, and Sept. 10, 2001, which go into effect Oct. 1, 2020.

**TRICARE:** Effective Jan. 1, 2018, Congress directed the DHA to implement TRICARE Select retiree enrollment fees in the National Defense Authorization Act of 2017 (NDAA-17), but delayed implementation of fees until Jan. 1, 2021 for Group A retirees. TRICARE Select Group A retired beneficiaries have not previously paid enrollment fees. If the sponsor's initial enlistment or appointment occurred before Jan. 1, 2018, they and their family members are in Group A. On Jan. 1, 2021 TRICARE Select Group A retired beneficiaries will have to pay TRICARE Select enrollment fees, via allotment, where feasible. For participants of another TRICARE plan, such as TRICARE For Life, this won't apply. Recently, affected participants should have been contacted to set up a monthly enrollment fee premium payment. Those getting retirement or other pay from a military pay center will pay TRICARE Select fees via a monthly allotment. If retired pay is not received through a military pay center, then fees will be paid by a recurring credit or debit card transaction. Monthly fees may also be paid through electronic funds transfer (EFT), but must come from a U.S. bank. **Some VA Benefit Services to Resume In-Person:** VA announced the reopening of in-person benefit services in select locations. Currently, 11 regional offices are open to the public. The reopening of other regional offices will depend on local conditions. They will follow CDC guidelines to include social distancing, face coverings, hand sanitizer, and asking sick individuals to stay home. Veterans can still access VA online or by phone.

**VA #FightFlu Initiative:** VA has expanded the options eligible veterans have on where they can receive a seasonal no-cost flu shot. CVS and Walmart are partnered with the VA, so if you get a shot there it will be in your VA medical record. Lake Nona VA Center has drive-through flu shots.

**How can I change my VA direct deposit information online?**

**Disability compensation and pension benefit payments**

If you receive disability compensation or pension payments from VA, you can update your direct deposit information in your VA.gov profile. You'll need your bank's routing number and account number to make the updates.

**Note:** You'll need to sign in to VA.gov to update your direct deposit information. Once

signed in, you'll have to verify your identity and set up 2-factor authentication only if you've haven't done this already.

## Gerard Thomas Dress—His Final Address

Gerry, as we all know him, was born in Scranton, Pa on 11AUG32 into a family of eight children. Gerry was involved with the Catholic Church while growing up and according to him, his mother wanted him to become a priest. He enlisted in the US Air Force and served over 9 years, including time in Japan during the Korean Conflict. As a radio repairman he told stories of climbing the towers to repair equipment as well as a time he taxied a fighter plane across the tarmac and getting in trouble. Gerry told his family that where ever he left the Air Force, that would be his final residence. Gerry was honorably discharged as a TSGT and from McCoy Air Force Base.

Gerry was much into public service to our Veterans as a Life Member of the American Legion, Life Member of Veterans of Foreign Wars. Many individuals did not know that Gerry was a member of the 6<sup>th</sup> District as Chaplain. He would constantly pay for flag pins, meals for veterans and made sure every veteran was welcomed. Sometimes his demeanor appeared to be rust, but it was always looking out for what was best for the Winter Park Memorial Post 112. Past Dept of FI Commander Steve Shuga remembers Gerry as always having coffee and day-old pastries and an opinion on all Legion matters.

He made sure as 2<sup>nd</sup> Vice CMDR of the Post that we had YOUTH PROGRAMS number one, whether it was the annual Halloween Party, or Easter Egg hunts. Celebration of the American Legion Birthday always had an open house and Gerry welcomed everyone. Centurion Battalion USNSCC was Grandpa Gerry's pride and joy, always making sure they had everything they needed as the liaison for the post. Gerry's most proud event was the FOUR CHAPLAIN'S CEREMONY held every year. The monthly Saturday breakfast was also special to Gerry and he made sure the members of the VA retirement home were taken care of. A post member whose funeral was during one of the breakfasts had all members outside to salute this veteran on his final ride to the graveside.

During the last approximately six years it has been my privilege to assist Gerry and keep him in his home. His desire to return to the post and work as 2<sup>nd</sup> Vice CMDR never stopped. His final days included his celebration of his 88<sup>th</sup> Birthday in which he was extremely happy with all the birthday cards sent by the membership. His concern for his two remaining Sisters one being 96 and the other in her 80's was always there, and he made sure he called them weekly.

Gerry was not perfect, but his love of mankind is above reproach. Mr. Gerry was interned at the Cape Canaveral National Cemetery with honors from the US Air Force and the Catholic Deacon.

My final thought is that if you read the poem **"THE DASH,"** Mr. Gerry exceeded that little DASH. You see Gerry was a true believer of SERVICE to others and especially the veterans of our military.
