

Simply swipe the included gauze pad under the arms or around the neck area and store the pad in our specially-treated jar. If you ever need it, you'll have the best possible location resource to present to emergency responders.

In June 2019, Scent Evidence K9 partnered with Alzheimer's Project to pass the **Bringing the Lost Home Project** bill in Florida to increase awareness and improve missing person response. The bill was passed into law by Florida Gov. Ron DeSantis and will serve residents and responders in Seminole, Sumter, and Bay Counties by providing Scent Kits, missing person awareness, specialized K-9 training and missing person response training.

ALZHEIMER'S DISEASE AND WANDERING



For people diagnosed with a memory disorder or family members caring for a loved one with Alzheimer's Disease, the dangers of wandering and getting lost are a major concern. Studies have shown that 6 out of 10 people with Dementia will go missing.

Florida has the second highest incident of Alzheimer's Disease in the nation - only behind California. There are over 520,000 individuals currently living with Alzheimer's Disease in Florida with that number projected to grow to more than 720,000 by 2025.



According to the Center for Disease Control (CDC), the prevalence of autism in U.S. children increased by 119.4 % from 2000 (1 in 150) to 2010 (1 in 68). The American Pediatric Association states that almost 50% of these children will go missing at least once before the age of 17.

Notes from Our Service Officer

On Friday, officials from the <u>Bureau of Labor Statistics</u> said the unemployment rate among veterans fell to 7.9 percent last month, based on its monthly employment surveys. That figure translates into about 700,000 veterans looking for work. In April, the first full month of the coronavirus pandemic in the United States, the number was <u>11.7 percent</u>, the highest monthly rate recorded by the agency in at least the last 20 years.

At the beginning of April 2020, as concerns about COVID-19 infections increased and the President declared a national emergency, VA suspended its in-person medical disability examinations for its compensation and pension (C&P) programs. On May 28, 2020, VA resumed in-person C&P exams in locations where it was safe to do so. VA has since expanded these in-person examinations to other locations based upon local COVID-19 risk assessments.

*If you require an in-person C&P exam and live in or near a resumed location, a VA contract medical exam provider will contact you.

Expansion of Caregiver Program Planned for Fall: VA released its <u>final rule</u> on revising its regulations for VA's Program of Comprehensive Assistance for Family Caregivers (PCAFC). According to the document, the expansion is set to begin Oct. 1, 2020. Under this rule, PCAFC will be expanded in two phases. The first phase is for caregivers of veterans injured on military duty before May 7, 1975. Veterans injured in service between 1975 and 2001 will have to wait two more years. With this final regulation, PCAFC will be open to veterans with a service-connected disability rating of 70% or higher.

Veteran COVID-19 Viral Testing Guidance for Community Care: Veterans can receive COVID-19 viral tests through VA health care facilities and community providers if they meet the criteria provided by the Centers for Disease Control and Prevention, and local public health department guidance. To be eligible for a community care provider, veterans must either be enrolled in VA health care or must be eligible for VA care. Veterans will not be charged a copayment for COVID-19 viral testing. Testing is available at community health care locations at in-

network urgent care/retail locations, if it is in conjunction with a clinical visit for care at one of the authorized care centers, **in-network community care providers**, with a referral or authorization, or **emergency departments**, if the visit otherwise meets criteria for VA coverage of emergency care services.

VA and the Elizabeth Dole Foundation teamed with CareLinx to provide more than 40,000 hours of non-medical home care respite relief for over 1,600 family caregivers of veterans in California, Florida, and Texas. Caregivers can apply for a qualified health care professional for 24 hours of free respite relief. CareLinx services include mobility, meals, house-keeping, exercise, bathing, toileting, medication reminders, companionship, and transportation.

VA Prepares to Welcome Back Volunteers: VA announced this week plans to gradually and safely reintroduce volunteers to its health care facilities.

Federal employees and military retirees will have more insurance plans to choose from this year, as the Office of Personnel Management announced Aug. 11 that it has selected the Federal Employees Dental and Vision Program insurance carriers that will be available for coverage in 2021. Those eligible for the FEDVIP program will be able to enroll, cancel or change their coverage during the 2021 open enrollment season, which lasts from Nov. 9 to Dec. 14 this year.

The Defense **POW/MIA** Accounting Agency announced two new identifications and two new burial updates:

Two - Marine Corps and Two - Army : Both from the Gilbert Islands.



Eagle Scout Project Helps Our Post

Why I Chose My Eagle Scout Project

The flag represents many things to me like valor, honor, pride, perseverance and justice. So when I was deciding on an Eagle Scout Project, I liked the idea of doing something to honor the flag. Our Troop has had people drop off their old and worn flags for us to properly retire them and many people do not know what to do with their unserviceable flags, so that's how I decided on what I wanted to do for my Eagle Scout Project. I do not think many other organizations appreciate the American Flag more than Veteran Organizations, so I talked to the American Legion and Veterans of Foreign Wars to see if they would be interested in receiving an American Flag drop box. I built three boxes, one for the AL Post 112 and two for the VFW (Posts 4287 and 10139.) The project will provide a needed service for people in the community to drop off flags that need to be retired properly. The section of the U.S. Code that governs the flag states that when a flag is no longer fit to be displayed,

it should be destroyed in a dignified manner, preferably by burning.

The drop boxes will be easily accessible so people can drop off their old flags that were once flown with pride, to be retired with dignity.

Hunter Campbell, another ScoutsBSA Troop 613 Eagle candidate, chose to honor the Four Chaplains who gave their lives helping to save sailors on the U.S.A.T Dorchester when the ship was hit by a torpedo just after midnight on February 2nd, 1943. Of the 902 servicemen, civilian workers and officers on board, 688 went to an unmarked grave. Today, the Chapel of the Four Chaplains serves the memory of these brave men and carries the message of interfaith cooperation and selfless service to every part of the country. Our Post first began holding Four Chaplain's services on the first weekend in February more about ten years ago under the direction of former Vice Commander, Gerry Dress. The memorial created by Hunter and

his team will be a permanent part of our future Four Chaplains ceremonies and serves to honor Gerry's dedication to the Four Chaplains.
