Buyer Beware—Bob Colbert

Watch out for those "TAX CREDITS" and SALES PRESSURE.

Many of us are retired or on fixed income, so we watch the pennies. And, when someone comes around to sell something like solar panels or replacement windows, they often refer to "TAX CREDITS" to get some of the cost back. But there is a "caveat" that they may not think of, and neither would you, especially if the salesperson has a dynamic personality. **There could be a catch!** Think about how much you paid in Income Tax last year, or how much you got back. In many cases, **if you didn't pay into the IRS the amount of the credit, you can only get back what was paid in.** This may or may not apply, but you need to check. **AND THE SALESPERSON IS NOT YOUR TAX ATTORNEY!!!! And, neither am I. Every case is different, so you need to check it out!** Often the salesperson will tell you that you can make your purchase and send them the "lump sum" of your "tax credit" to offset some of the cost of a loan. If you don't pay this "lump sum" you may have a substantially higher payment to make. **PLEASE WATCH OUT FOR THESE ALTERNATIVES** and remember "Murphy's Law." Your tax attorney or accountant can tell you what repairs or improvements are eligible for TAX CREDITS, so please check with them.

Salespeople are there for one reason – to make the sale! If it is a major change for your home, get another estimate! If the salesperson says that this is a **LIMITED TIME OFFER**, there is something wrong and you should view this as a possible RED FLAG. If possible, always get at least one other estimate on any major repairs or improvements.

The term "buyer beware" applies more today than ever before. Don't get stung. "Buyers remorse" can have lasting effects.

Notes from Our Service Officer

Service Officer Notes: **October 2021**

The Department of Veterans Affairs will resume over-payment notifications for new benefit debts and the debts deferred from April 6, 2020 through Sept. 30, 2021 due to the COVID pandemic. VA suspended debt collection April 6, 2020 and will restart debt collection Oct. 1, 2021, however, VA will not deduct debts from benefits payments until January 2022. Debt notification letters sent to affected Veterans and beneficiaries will include options to request debt relief for those who continue to need financial relief from the impacts of the COVID-19 pandemic.

VA #FightFlu Initiative: VA has expanded flu vaccine availability to more than 70,000 in-network community providers.

TRICARE Pharmacy Copayments to Increase in 2022

TRICARE Pharmacy Home Delivery (Up to a 90-day supply)

Generic formulary drugs will increase from \$10 to \$12

Brand-name formulary drugs will increase from \$29 to \$34

Non-formulary drugs will increase from \$60 to \$68

TRICARE retail network pharmacies (Up to a 30-day supply)

Generic formulary drugs will increase from \$13 to \$14

Brand-name formulary drugs will increase from \$33 to \$38

Non-formulary drugs will increase from \$60 to \$68

The Defense Department is asking as many as a half-million ID card holders to go online now and make appointments to renew their IDs — many of which are past the expiration dates printed on them. DOD extended the expiration dates electronically to account for the challenges of renewing them in a COVID-19 environ-

ment. Last year when it became apparent that COVID-19 was going to dramatically affect the ability of individuals to congregate or wait in line at ID card offices, the Defense Department electronically extended the expiration dates for many ID cards for several months to allow cardholders a greater amount of time to get those cards renewed. The extensions primarily benefited the dependents of active-duty service members, Reserve and National Guard service members and their dependents, as well as retirees and their dependents. Currently, there's a backlog of more than a half-million people who have ID cards that are past the expiration dates printed on them. The cards of retirees and their dependents can be used until Jan. 31, 2022.

Cost of Living: Veterans may be in line for a big cost-of-living boost in their benefits payouts starting in December thanks to legislation finalized by Congress on 20 SEP. The Veterans' Compensation Cost-of Living Adjustment Act passed unanimously in the House on Monday and without objection in the Senate earlier in the summer.

VA Blue Water Claims Update 87: VA OIG Reports Many 'Inaccurate Decisions' A sampling of thousands of VA claims filed primarily by veterans who served in the waters off Vietnam showed about 46% were inaccurate, resulting in over- or underpayments to a group familiarly known as Blue Water Navy veterans. Of the 4,600-claim sample highlighted in a 43-page report by the VA's Office of Inspector General 2,100 veterans "had inaccurate decisions," the report states. This resulted in \$25.2 million in overpayments and \$12 million in underpayments. The bulk of the errors — 95% — "involved [Veterans Benefits Administration] employees not following general rating policies, such as inaccurately assigning retroactive effective dates for evaluations." Servicemembers aboard vessels operating as far as 12 nautical miles from the

Vietnam coast, as well as those who served in the Korean Demilitarized Zone, are presumed to have been exposed to herbicides and may be eligible for benefits connected to conditions related to that exposure. VA officials also said staffers underwent additional training on the claims process. Veterans with improperly processed claims will receive notification from the VA. Underpaid veterans can expect a letter stating they'll receive retroactive payments via the same method they receive their regular VA compensation. Overpaid veterans will get a letter explaining the error and giving them 60 days to reach out to the VA's Debt Management Center to arrange a repayment plan. If

the center doesn't hear from the veteran in 60 days, it will send a letter notifying the veteran of plans to recoup the funds.

VA Claims Backlog Update 169: Expected to Grow In Coming Months Veterans Affairs officials don't know how bad the backlog of veteran disability claims will get this fall, but they know it's getting worse. The backlog ..defined as the number of first-time disability and pension claims that have been awaiting decisions for more than four months — topped 215,000 this week, up 16 percent since July and nearly triple what it was in early 2020 before the coronavirus pandemic in America. In a press conference with reporters on 15 SEP, VA Secretary Denis McDonough acknowledged that the problem

is going to get worse before it gets better. "We anticipate the backlog to further increase this fall as we process claims for new presumptive conditions from the Vietnam and Gulf wars," he said. "We're in the field fulfilling those claims now. but we want to keep warning our veterans about what to expect, so they see what's coming in the same way that we do."
