Please remember that our eligibility requirements have changed—the male spouses of female Veterans are now able to join the Auxiliary as long as their living spouse is a Legion member. Also, Veterans can join the Legion if they served at any time after the beginning of World War II. If you know of community members who are eligible for the Auxiliary, the Legion, or SAL, please encourage them to join our Winter Park family.

We have begun receiving Americanism essays from our schools. So far, we have entries from Cheney and Dommerich Elementary schools and we've been promised entries from students at Winter Park High School. Copies of the essays from the elementary schools were emailed to our members. Please review them and send the names of your top three essay writers per school to Nell as quickly as possible. necolbert@usa.net. Our essay judging will take place after our Girls State interviews on 2/27 and having your choices before then will make our selection process go more smoothly.

And speaking about Girls State, as of the writing of this article, we have five candidates to interview, two from Haggarty High and three from Winter Park. Our interviews will be conducted in person at the Post on Sunday, 2/27 beginning at 2pm. Unit members should arrive by 1pm to help set up the room and the pavilion. This is always an exciting time of the year for our Unit as the candidates we interview are always top notch and deciding on our delegate and alternate is never an easy task. Look for pictures in the next newsletter as this one will be printed before our interviews are conducted.

It seems hard to believe that we are quickly coming to the end of our 2022 program year! Beginning in late March we will be contacting our elementary schools about naming students to receive our Auxiliary Scholastic Achievement Awards. We present certificates and medals to one young lady and one young man at each of the seven elementary schools we serve during their 5th grade awards ceremonies at the end of the school year. This year, these award ceremonies will be conducted in person so we will need help from our members to get the medals presented. The schools tend to select the last two or three days of school for the awards ceremonies and due to the distance and travel time between the schools, it is very difficult for any one person to

And because it is the end of the program year, we must begin to think about the 2023 program year and our officers for 2023. Notes from Our Service Officer

The House Veterans' Affairs Subcommittee on Economic Opportunity held a hearing focused on the impact of new VA education and training programs such as [Veteran Employment Through Technology Education Courses](#) (VET TEC) and [Veteran Rapid Retraining Assistance Program](#) (VRRAP) in securing veteran employment. Since its launch in 2019, VET TEC has placed over 1,700 graduates in new employment, earning an average salary of \$60,000.

The Senate Committee on Veterans' Affairs unanimously passed the *Health Care for Burn Pit Veterans Act*, this legislation would extend VA health care eligibility for combat veterans from five to ten years after separation from the military. The bill would require VA to screen veterans regarding their exposures during service, furnish training for VA health care providers and disability claims processors, and provide additional reporting and tracking of veteran health conditions due to toxic exposures.

Department of Veterans Affairs officials are hoping a new automated system that helps render decisions on disability claims will accelerate the process and decrease the backlog of claims applications. VA officials said the program is part of a plan to address 260,000 current disability claims, including 59,000 that are older than 125 days and are considered backlogged. After the pandemic began, the number of backlogged claims rose from 70,000 to 211,000. While the VA reduced that to roughly 180,000 by mid-2021, the number grew again as veterans applied for benefits under an expansion of covered conditions, including illnesses related to Agent Orange and airborne pollutants. VA Secretary Denis McDonough said 18 JAN that the department has hired more than 1,000 new claims processors and plans to hire roughly 1,000 more by the end of spring.

The Department of Veterans Affairs roll out of a

new \$16 billion electronic health records system is being delayed again, but this time Covid-19 is the reason. The VA medical center in Walla Walla, Wash., is still on track to begin later this spring. But officials admitted that if the latest surge in coronavirus cases lingers, it could disrupt other parts of the schedule. The tentative timeline has the new records system being used in 12 VA medical centers by the end of 2022 and 21 more by the end of 2023.

Lawmakers are demanding reforms in how Veterans Affairs officials screen outside doctors for patient medical care after a recent Government Accountability Office review found the department's referral list contains about 1,600 providers that are ineligible to treat veterans, - 25 - including 601 who are dead. "While [the list] represents a small percentage of the Veterans Community Care Program's roughly 1.2 million active providers, they represent potential threats to veteran health and safety and risks for financial fraud.

House lawmakers on 20 JAN advanced legislation that would automatically enroll separating service members into the Veterans Affairs medical system, an effort to streamline their access to that care if they need it. The measure would affect about 60,000 individuals a year. Instead of formally applying for VA medical services, department officials would automatically add them to the system if they met the requirements for eligibility.

The Defense **POW/MIA** Accounting Agency announced one burial update and six new identifications.

1 Burial: Army, New Guinea. 6 Identifications: Army, Biak Island, Germany, and North Korea.

2023 Nominations and Elections

It is coming upon that time of year! Our elections for Commander, Vice Commanders, Historian, Chaplain, Finance Officer and Sgt At Arms will be coming up soon. Should you be interested in any of these positions including what their duties are, I can send you the “job description” via email or mail it to you if you do not have email. One thing to remember is that the elected officers are expected to attend the meetings either in person or online.

The nominating committee consists of volunteers from the membership. The Adjutant is the chairperson as he is not elected. We can have up to five members of the committee. We hope to have the committee formed by the end of the April meeting so that we can begin assembling the “slate of officers” to be voted upon at the June meeting. Nominations can be made from the “floor” at the May meeting. The nominations are closed after the May meeting, the election will be held at the June meeting. This gives the candidates a month to “campaign” if they wish.

The Constitution and By Laws for the Post are available on the WEB site, and you can find the descriptions there, too.

The election process will be done by voice/visual ballot unless this presents a problem. Only paid (2022) members of the Son’s Squadron or the Legion Post will be able to vote at their appropriate meetings. The Adjutant will verify membership for physical and online members. The By Laws of both organizations permit online attendance to be counted for valid for voting. Should a paper ballot be required, the election will take place as scheduled but the results will be slightly delayed as the members online will have to submit their ballots by email. Only those members who attended the meeting will be counted and a roster of those attendees will be kept by the Adjutant. Email ballots must be submitted within two hours of the meeting’s end to be counted. All ballots will be retained until at least after the installation of officers.

The installation of officers has traditionally been conducted at the Post’s July meeting, where the new and continuing officers will be sworn in. The swearing in ceremony is conducted for the Legion, Auxiliary and the Son’s Squadron at the same meeting. Officers who are not able to attend in person are expected to join us via the ZOOM system.

School Medals



Spring is the time of the year when Post 112 and Unit 112 are handing out school medals and WE NEED YOUR HELP!

The Post presents medals and certificates to one boy and one girl at seven elementary schools, one middle school and two high schools. We need some help presenting these medals as many of the schools hold their ceremonies on the same morning at the end of the school year. For the last two years, the awards ceremonies have been held virtually so awards were dropped off at the schools—no presenters were needed. This year they will be held in person at each school towards the end of May or the first part of June. If you have the time, contact Bob Colbert, Adjutant, to let him know that you are interested in helping. When he hears from the schools, we can coordinate the dates and times.

Boys State candidates were interviewed on February 26th at the Post. Since this is being written before the interviews and will be read after the interviews, it is a little hard to speculate. We had reached out to Winter Park High School and Lake Howell High School and only Winter Park High School responded this year thus far.

Traditionally, the Post is allotted two slots and we have opted for

two more so that there are effectively four delegates sponsored by our Post. We also select four alternate slots in the event that one or more of the primary candidates is not able to attend. Prior to COVID, we had the youth come to the Post's General Meeting on the second Tuesday in February to be interviewed. Last year, with COVID, we handled the interviews by ZOOM and it worked out well considering the conditions. This year, we

held the interviews at the Post. In the event that we were not able to fill all four candidate slots, the Department has a list of alternates from across the State and can make certain that the slot(s) are not wasted. If we were not able to fill all four slots, it will be the first time in many years that we have not.

Elected Officers—Roles & Responsibilities

Here is a list of the Elected Positions. To give you some idea, here is a very brief overview of the positions and their roles and responsibilities.

Commander – chairs both the General Meeting of the Legion as well as any Executive Board meetings that are held. He or she also prepares an agenda prior to the meeting and sends it to the Board.

First Vice Commander – Chairs both meetings in the event that the Commander is not available. He or she also handles the membership and sends out the member's cards as well as reminders when members forget to renew their membership.

Second Vice Commander – He or she is the “backup” when neither the Commander nor the 1st Vice Commander are available to chair the meetings. They also oversee the Post property and organizes the staffing for any work that needs to be done at the Post. This officer also works with the Commander to organize events that are held at the Post.

Sergeant At Arms – He or she is the “gatekeeper” for meetings. It is an important role in the actual meetings as well as at any events that are held at the Post. This officer leads the membership in the Pledge of Allegiance at all meetings and is the flag bearer for the POW/MIA flag at meetings.

Finance Officer – He or she is responsible for seeing that all monies are properly handled, and all bills are paid in a timely manner. This officer reports to the membership on the state of accounts at each Board and General meeting and must also see to it that all licenses, taxes, and corporate filings are done correctly and on time.

Chaplain – This important job consists of checking the wellbeing of the membership and Post Family. He or she is the “go to” person when a Post member becomes ill or hospitalized and maintains regular contact with the members who are not able to come to the Post due to health issues. This officer reports back to the membership at the General Meeting on any members they are aware of that may have become ill or hospitalized. They also may be called upon to help with funeral preparations from the Post's standpoint and may also visit and assist with some members who are ill or hospitalized. The Chaplain will also handle other such duties as may become necessary.

Historian – This important position has unfortunately been vacant for a while. The Historian collects pictures, news articles and other information about the activities of the Post. This person may not be the one to take the pictures but can request them from those members who attend the functions. In the digital world, he or she may be able to have our members forward articles found as well as scan copies of “Programs” from events that are held. The Department of Florida holds an annual “Scrap Book” contest at the Annual Convention and the winner's book is sent on to National.
