## Notes from Our Service Officer

The president has enacted historic Uniform Code of Military Justice (UCMJ) reforms aimed at holding more offenders accountable for crimes. Passed as part of the National Defense Authorization Act for Fiscal Year 2022, changes to the military justice system include placing prosecutorial decisions for cases like sexual assault and child abuse in the hands of independent prosecutors instead of unit commanders, as has been the status quo. The new rules come on the heels of recommendations from the 2021 Independent Review Commission on Sexual Assault in the Military, and years of effort by advocates and lawmakers to increase process fairness and justice for victims of sexual assault and other serious offenses.

The Department of Veterans Affairs announced it will conduct a scientific review to determine whether there is a relationship between three conditions - acute leukemias, chronic leukemias, and multiple myeloma outside of the head and neck — and toxic exposures for service members who deployed to Iraq, Afghanistan, Somalia, Djibouti, Egypt, Jordan, Lebanon, Syria, Yemen, Uzbekistan, and the entire Southwest Asia theater of operations. The review will help VA determine whether these conditions will be considered presumptive for veterans. This presumptive framework was a key provision of the PACT Act. VA claims processed by the PACT Act has processed more than 760,000 claims and paid out \$1.6 Billion to Veterans. About 111,000 veterans who are believed to have toxic exposure have enrolled in VA health

care since the law was enacted. In addition, more than 4.1 million veterans have completed toxic screenings, which are questionnaires to analyze their potential exposure and determine whether additional tests are required.

## Who do I contact When I Have a TRICARE Billing Question?

It depends on what the bill is for (medical, dental, or pharmacy services). After you visit a doctor, dentist, or pharmacy, you get an Explanation of Benefits (EOB). You get:

A medical EOB for a medical visit.

• A Dental Explanation of Benefits (DEOB) for a dental visit.

A prescription drug EOB for a pharmacy visit.

EOBs aren't bills. It's an itemized statement that shows how TRICARE paid on your claim and what you owe your provider (if anything). If you get a bill from a provider, check your EOBs and DEOBs to see if you owe the provider. If you still have questions after you review your EOB or you don't have an EOB for the bill you got, call your TRICARE contractor.
