Notes From the Adjutant's Desk

Spring is here! With Spring comes several activities that could use your help. There is Memorial Day in May and Fourth of July coming up. There are no plans yet, and any help and/or suggestions would be welcomed. There are more events possible in the Fall.

By the time you see this, our Boys State selections will be completed. The selection for the Boys State was done on Feb 24th and the selection for Girls State, done by our Auxiliary Unit, was done on Feb 25th. The Post is sending four boys, and the Auxiliary is sending two girls and two alternates. See the articles later in this newsletter for pictures of our candidates.

Elections are coming up. Nominations will be accepted at the April meeting and the election held at the May meeting. If you are interested in any position, please let me know before April 1st. The open positions are Commander, 1st Vice Commander, 2nd Vice Commander, Chaplain, Finance Officer, Historian, and Sgt at Arms. Space permitting, we will have an article about the various positions. Chair positions are filled out by the Commander after his election, but you are encouraged to let him know if you are interested. The chair positions that we have are Children & Youth, School Medals, Oratorical, Boys State and Scouting. These are appointed positions so there is no election needed. If you are interested in any of these positions, contact me for a description.

National has announced dues increase for the 2025 membership year of \$5 per person. We have not heard from the Department as to an increase for them. The Post has absorbed the past increase, but we are not able to absorb this one. The Post will have to increase membership fees to \$45/year to keep up with the increases. BUT here is a savings for YOU! National has allowed those who pay their dues online to pay multiple years at TODAY'S rate. You can only do this

online and if you need assistance, please contact me. We can do it at the Post if you do not have access to a computer or do not understand how the renewal works online. If you have already paid for 2024, you can still pre-pay for 2025 and 2026 online. If you need help, let me know.

Have you wanted to attend the meetings but don't want to drive at night? You know that our meetings are all broadcast over ZOOM. But maybe you don't have a computer or don't feel comfortable trying to access ZOOM on it. **You can use your CELL PHONE!** Yes, any **CELL PHONE** can "dial in" to the meeting and participate. All you need to do, when you want to attend the meeting is dial 1-305-224-1968 and when it asks for a meeting ID, enter 862-8807-1778 AND if it asks for a PASSCODE, enter 764023. This can be done from any cell phone. **If you call in from a "wire" phone, there will be long distance charges.** And if you are using a computer, the shortcut will be sent out the week or weekend before the meeting. Using a computer or smartphone allows you to see everyone who is online except those using a CELL PHONE (no camera). If you need any help or want to test it out, let me know before the meeting time.

Remember, our By-Laws allow for "remote attendance" for all members and the ZOOM system allows us to verify who is attending and voting even online.

And speaking of By-Laws, our Constitution and By-Laws need to be reviewed and if necessary, updated. Does anyone want to help with this project? It is tedious work but maybe we can try to make it fun. Let's talk about it.

I hope to see you at the meetings or at least on ZOOM. Remember, your voice and vote count!

Notes from Our Service Officer

A Claim Shark is an individual or company that charges hefty fees to “assist” or “consult” veterans and survivors with filing their VA benefits claims. This practice is illegal! In fact, none of these private companies is better than the others. They are all operating illegally. Claim Sharks are not VA-accredited, meaning they are not required to adhere to professional and ethical standards, so their advice can be misleading or even fraudulent.

The VA Health Chat app enables you to easily chat with VA staff online to ask questions about your health concerns. You can use [VA Health Chat](#) to receive medical advice for non-life-threatening injuries or illnesses, schedule VA appointments, refill VA prescriptions, and more.

We are excited to announce that a new Admin/Scheduling channel is now available on VA Health Chat in your VISN. This channel will enable you to ask administrative questions, schedule appointments, and more, and receive responses from VA staff in minutes. In addition to the new Admin/Scheduling channel, you will continue to have access to the Nursing, Pharmacy, Urgent Care, Whole Health, and Women’s Health channels.

You can chat with VA staff in most participating locations Monday to Friday, 8 a.m. to 4 p.m. local time, excluding federal holidays. In some locations, staff are available 24/7.

[page](#) or [sign in to My HealtheVet](#). A blue VA Health Chat message box will appear in the lower right corner of the My HealtheVet page if the app is available to you. For security reasons, you’ll need to sign in to the app with VA-supported credentials. You may use your [My HealtheVet Premium](#), [DS Logon Level 2 \(Premium\)](#), [ID.me](#), or [Login.gov](#) account.

The American Legion is calling on members of the American Legion Family to [contact their members of Congress](#) and urge support for H.R. 3651, bipartisan legislation designed to allow surviving spouses of military servicemembers to retain survivor benefits should they remarry.

The extension of the COVID-19 Refund Modification program enables veterans to obtain zero-interest, deferred-payment loans from the VA, covering missed payments and modifying existing VA-guaranteed loans for an affordable monthly payment structure. The VA is establishing a VA Servicing Purchase program to purchase defaulted VA loans, modify them, and include them in the VA’s direct loan portfolio. Veterans struggling with mortgage payments are encouraged to visit the department’s [housing assistance website](#) or call 877-827-3702.

Boys State—Bob Colbert

It's that time of year! We have polled the schools (Winter Park High School, Lake Howell High School and Trinity Preparatory School) and they have provided some candidates for our interview process. We have paid for our four candidates and that would also allow for four alternates. The names of the four candidates and alternates will be sent to the Department of Florida so that any Post that was not able to fill their quota can contact one of our alternates to attend Boys State. In the past, all of our candidates and alternates that wanted to attend have been able to attend.

We held our candidate interviews on Saturday, February 25th and we selected quality candidates again this year.

As you know, Boys State is a program of the American Legion where students between their Junior and Senior year of high school spend one week in Tallahassee acting as State and Local Government officials. They assume the duties of the positions that they are elected to in a "fictitious" state for the week, using the facilities of State Capitol, House and Senate chambers State Supreme Court chambers and other facilities within the State Capitol complex as needed and available. They will be learning local government operations from the city, county and state levels throughout the week. Two candidates will be chosen from all of the attendees to go on to a similar event at Boys Nation in Washington, DC. Usually, they are welcomed by the actual Governor at the beginning of the week. Each candidate is asked to write a "bill" on something that is a concern of his and present it through the legislature. Bills that are passed through for the youth governor to sign are often passed on the State Legislature for consideration at the next session.

Duties of Officers

We are coming up on our election of officers! The election will be held in May with the final nominations closing in April. The nominating committee will present its candidates and then open the floor to other nominations. This is the time for anyone else who would like to run for office. The installation of Officers will be held at the July meeting.

So, are you interested in running for office? The positions and a summary of their duties are:

Commander – Presides at the meetings and represents the Post at District meetings and other Post, District and Department functions. The Commander is also responsible for insuring that there are chairs for the committees and programs that the Post has chosen to follow are populated.

1st Vice Commander – Our First Vice Commander is responsible for presiding over the meetings in the absence of the Commander. He or she is also the “DeFacto” Membership Chair. The First Vice also researches and coordinates the guest speakers at the meetings with the Commander. The 1st Vice also would be the key person in arranging for the members who do not come to the Post very often are checked on by phone or in person.

2nd Vice Commander – Our Second Vice Commander is responsible for the physical Post. The 2nd Vice works with the Commander to maintain the property and make recommendations for changes or improvements and works closely with the Adjutant to coordinate activities at the Post. If there is a cost involved outside of the budget, the Second Vice presents the item to the Post’s Executive Board. Additional volunteers may be recruited to assist in any of the projects needed to maintain or improve the Post.

Chaplain – The Chaplain is responsible for the opening and closing prayers at all formal meetings. He or she is also expected to check on and, when possible, visit those members who have fallen ill. The Chaplain is also expected to take the lead (chair) in the annual Four Chaplains Ceremony and “Post Everlasting” ceremonies that the Post performs twice a year. In the event of the passing of a member, the Chaplain would be expected to assist the family with the military or VA portions of the arrangements where possible or necessary.

Finance Officer – The Finance Officer is responsible for all deposits and withdrawals involving the Post’s Finances. The Finance Officer prepares a monthly financial report to be presented to the General Membership at the monthly meetings and is also responsible for making sure that all the State and Federal requirements are met, including filing the IRS Form 990 and the State Corporation renewal as well as any State Sales Taxes that need to be filed. The Treasurer should be familiar with QuickBooks as that is the current bookkeeping system in use.

Historian – This person should be able to attend most of the Post’s functions and meetings and take pictures of significant events. The Historian also maintains the annual “Scrap Book.” The Historian can work with the newsletter editor in exchanging photos and stories.

Sergeant At Arms – The Sergeant at Arms ensures that members sign in for meetings and that they are current members of the Post. Members with expired membership cards may be excluded from voting at the meeting. The Sergeant At Arms also handles the POW/MIA empty chair ceremony and leads us in the Pledge of Allegiance.
