Notes from Our Service Officer

Reminder for VA Secure Sign In:

VA has issued changes for signing into your VA.gov or My HealtheVet accounts. Currently, there are four ways to sign in to your VA accounts: LOGIN.GOV, ID.ME, My HealtheVet, and DS Logon. Both My HealtheVet and DS Logon will be discontinued for accessing VA accounts. My HealtheVet sign in will be available until Jan. 31, 2025. Veterans, family members, caregivers, and survivors with VA accounts are encouraged to transition how they sign in to access these accounts prior to that date.

We encourage you to create a Login.gov or ID.me account now. If you already have one of these accounts but haven't yet used it, start now so you have time to get used to it before the change. With Login.gov or ID.me, you'll have access to all the same information and services you use today.

Here's what will change for Veterans and beneficiaries like you:

+ After January 31, 2025, you won't be able

to sign in to VA.gov, VA mobile apps, or other VA online services with a **My HealtheVet** user ID and password. After **September 30, 2025**, you won't be able to sign in with a **DS Logon** username and password.

✦ You'll have 2 sign-in account options that meet modern security standards: a Login.gov or ID.me account. You'll be able to use your account to sign in to VA.gov, VA mobile apps, and any other VA online service to manage your VA benefits and care.

You'll need to use a unique email address and set up multifactor authentication for your account as part of the requirements of both **Login.gov** and **ID.me**.

Your **My HealtheVet** health portal isn't going away. You'll just need to sign in to it with a **Login.gov** or **ID.me** account.

The Defense **POW/MIA Accounting Agency** announced 3 identifications and 5 burial updates for service members who have been missing and unaccounted for from World War II and the Korean War.

As usual, the guys shopped for





Boys State—Bob Colbert



We are off and running! We should have at least four candidates from Winter Park High School, three candidates from Lake Howell Hight School, three candidates from Trinity Prel and one candidate from Bishop Moore High School.

The school has the candidate criteria and will send us the names. We will do a "pre-interview" ZOOM call with the candidate and a parent to be sure that the parent understands what Boys State is and is comfortable with their son going to Tallahassee for a week. They also have a chance to ask questions about the event and the process at that time. It is important that the parent understands what is happening to ensure that the selected delegates are able to attend and that there are no family conflicts with the timing. Boys State is a non-stop activity from the time that they arrive in Tallahassee until they leave.

After the "pre-interview," we will hold the actual competition at the Post on

February 22nd. That is when the candidates will be interviewed by members of the Post. We will select four delegates and three alternates to actually attend Boys State. The alternates need to complete the entire registration just like the delegates as we often have our alternates chosen by the Department of Florida American Legion to fill in slots of other Posts that were not able to find delegates. Each Post pays in January for the number of delegates that they want to send but often Posts are unable to fill all of their slots. That is where the alternates come in.

Once the selections are made, the youth have a list of things that must be done. Permission slips, medical releases and other "technical" stuff plus the information about each of the delegates must be submitted to Boys State. There are scholarships available to delegates for college and other "perks" that will be available.

There is no cost to the delegate or alternate as the American Legion Post that sponsors them has already paid for them to attend. The delegate or alternat packet will have all of the information as to what to bring with you and what to expect.

The next step after completing registration is the Orientation session. This is done on a Saturday morning and lasts a couple of hours. The delegates from the Orlando metro area all gather to learn more about the event as well as when the bus will be picking them up and the time and date of departure. All delegates and alternates MUST ATTEND the orientation because this also ensures that their names are on the list. This orientation is usually held in April or May and the date will have been set by the time that we make our selection. Then it is off to Tallahassee in June!

The Post does ask that each of our delegates come back to the Post for our August meeting to tell us about their experiences. They will be able to meet the Girls State delegates who will also be telling the Post and the Auxiliary about their experiences,

We would like to have at least 5 "judges" at the interviews on February 22nd. If you have a couple of hours that afternoon, we would appreciate your help. Scoring sheets will be provided and will be tallied so that the candidates know who the delegates and alternates are. They will receive their registration packets, and you can help make these selections.

Let the Adjutant know if you are available to help us select our delegates and alternates on February 22nd. If you have any questions, please contact me by phone, text or email.



Cure Diabetes License Plate

Good afternoon,

I hope you are doing well.

I attended Florida Boys State in 2021 and had my bill unanimously passed in the mock House and Senate. After 3 years of working with legislators, the bill was signed into Florida law this summer.

The purpose of my bill is to introduce a Cure Diabetes specialty license plate, with all of the money going strictly to cure research for Type 1 diabetes. The money goes to the Diabetes Research Institute (at the Miller School of Medicine at the University of Miami), the University of Florida Diabetes Institute, and Breakthrough T1D (formerly JDRF).

Now, we need 3,000 presale vouchers for the license plate to go into production. They can easily be purchased online for \$33 by anyone with a vehicle titled in their name in Florida. I attached an image of the plate below and a FAQ document containing the link to purchase vouchers (<u>https://county-taxes.net/fl-escambia/vouchers</u>).

As a Boys State alum, I would greatly appreciate any help getting this information distributed to as many people as possible. Thank you for giving me the confidence to make a difference with this legislation.

Frequently Asked Questions – PRE-SALE CURE DIABETES LICENSE PLATE VOUCHERS as of October 2024

What is a pre-sale license plate voucher?

The State of Florida legislature set for a minimum of 3,000 pre-sale vouchers to be sold before a specialty license plate can be submitted to the Florida Department of Highway Safety and Motor Vehicles for production.

What is the cost of a pre-sale Cure Diabetes license plate voucher?

The cost of the pre-sale Cure Diabetes license plate voucher is \$33. If paying with a credit or debit card, a convenience fee will apply. The Tax Collector does not keep any portion of the convenience fee. Paying by eCheck is free.

Where does the money for the Cure Diabetes license plates go?

Of the \$33 charge for the Cure Diabetes license plate, \$25 is to be distributed equally among the following organizations to be used for research for a cure for Type 1 Diabetes:

the Diabetes Research Institute Foundation, which supports the Diabetes Research Institute at the Miller School of Medicine at the University of Miami;

JDRF International Incorporated, which supports the JDRF Northern Florida Chapter (JDRF is now known as Breakthrough T1D); and

the University of Florida Foundation, Inc., which supports the University of Florida Diabetes Institute.

The Florida Department of Highway Safety and Motor Vehicles provides a Monthly Revenue Collections Report with additional information.

How can I purchase a pre-sale Cure Diabetes license plate voucher?

The pre-sale Cure Diabetes license plate vouchers should be available at all Florida tax collectors' offices. However, the counties vary on how user-friendly they are for ordering vouchers, so it may be easier to purchase on-line at <u>https://county-taxes.net/fl-escambia/vouchers</u>. Scroll down to the Cure Diabetes license plate, and follow the prompts. You will be asked for the Florida license plate number for your vehicle. You do not need to reside in Escambia County to purchase or redeem the voucher; the voucher may be redeemed in any Florida county when the plate is in production. It is recommended that you save a copy of your payment confirmation for the purchase of your voucher. **PLEASE DO NOT USE THIRD-PARTY VENDORS AS THERE HAS BEEN ON-LINE FRAUD.**



Will I receive a document called a "pre-sale Cure Diabetes license plate voucher"?

No. The pre-sale Cure Diabetes license plate voucher will be attached to your driver record in the State of Florida's registration system. You will be able to redeem it once the Cure Diabetes license plates are produced and you request the Cure Diabetes license plate at time of renewal or as an ondemand license plate replacement. It is recommended that you save a copy of your payment confirmation for the purchase of your voucher.

May I purchase a pre-sale Cure Diabetes license plate voucher for someone else?

Yes. The recipient must have a vehicle titled in their name in Florida. If you are using the website provided above, enter the recipient's name and license plate number when prompted. If you purchase a voucher for someone who does not have a vehicle registered to them in Florida, you will not be able to get a refund for this purchase.

I've bought a pre-sale Cure Diabetes license plate voucher. Should I renew my registration?

Yes. Renew your registration and wait for the new Cure Diabetes license plate to become available.

If you purchase a pre-sale Cure Diabetes license plate voucher, it may be a year or more before the Cure Diabetes license plate meets its voucher goal and is manufactured. Don't wait to renew your registration during this time. Once manufactured, you will receive a letter from the Florida Department of Highway Safety and Motor Vehicles with instructions on how to exchange your current license plate for your newly approved Cure Diabetes license plate.

What if a specialty license plate doesn't meet the pre-sale requirement?

If a specialty license plate fails to meet the minimum presale voucher requirements, you may apply the presale voucher toward a different specialty license plate. You may also <u>apply for a refund</u> for the specialty license plate fee only. Pre-sale vouchers are non-transferrable.

What is the yearly cost for a Cure Diabetes license plate?

Once you have switched to the Cure Diabetes license plate, the cost will be the annual renewal fee plus the specialty plate fee will be \$33. If renewing on-line, there may be a convenience fee charge.

Are there vehicles that cannot use a specialty plate?

Yes. The following vehicles cannot obtain a specialty plate: Commercial trucks required to have front and rear plates, truck tractors, government vehicles, and commercial trucks with a gross vehicle weight of 26,001 pounds or greater. Motorcycles and Handicap plates cannot have the specialty plate incorporated.

How can I monitor the progress of a particular specialty plate?

Sales data may be viewed at the Florida Highway Safety and Motor Vehicles website.


